### Product Information

POLI-FLEX® IMAGE are transfer vinyls with a fashionable design and unique surface finish. The ecologically inert polyurethane vinyl has excellent washing and cleaning properties and is preferred due to a pleasant textile touch. POLI-FLEX® IMAGE is suitable to transfer onto textiles such as cotton, polyester/cotton blends and polyester/acrylic.

POLI-FLEX® IMAGE can be cut with all current plotters. We recommend using a standard 45° knife. After weeding the cut flex vinyl is transferred by heat press.

The PET liner of POLI-FLEX® GOLD and SILVER (4212-4213) should be removed after cooling down.

Nylon and textiles with hydrophobic impregnation are not suitable for heat transfer. In this case we recommend using POLI-FLEX® NYLON.

**We recommend evaluation on test material.**

Due to the various influences which occur from production and transfer of plotter letterings, consistency of the carrier materials and also washing and cleaning conditions, product liability can only cover the unprocessed material.
